

Directions to the Test Site

FROM THE SOUTH: Take either I-71 or I-77 North to I-271 North. Follow 271 North and exit at Mayfield Road (322) Go East. It is approximately 12.4 miles from that point to the test site. Proceeding east on Mayfield/322 you will cross Rt. 306. Soon you will see the Alpine Valley Ski Resort on the left. Drive 0.7 miles from there and turn right onto Auburn Road. Go 0.6 miles and you will see a green chain link fence on the right. Also on the right will be a sign for Notre Dame Educational Center. Immediately on the left is the driveway marked with tracking flags, the old preschool. Turn left into the preschool parking lot. You have arrived!

FROM THE NORTHEAST: Take I-90 west towards Cleveland. East of Cleveland Take I-271 south and follow the directions above.

FROM THE NORTHWEST: Take I-90 east. East of Cleveland Take I-271 south and follow the directions above.

FROM THE HOTELS LOCATED NORTH OF THE TEST SITE (AT I-90 AND RT 306): From this intersection it is approximately 8.8 miles to the intersection of Rt 306 and Rt 322. Take 306 South, crossing Rt 6 and Sherman Rd. The next large intersection is Rt 322. Turn left there and follow the directions above to the test site.

FROM THE HOTELS SOUTH OF THE TEST SITE: Get back on I-271 North and follow directions above.

ENTRY FEES \$170.00 (VST) or \$135.00 (TDX) Send a separate check for each entry (for 2 different dogs). Make checks and money orders payable (in U.S. Funds) to the Buckeye Tracking Club and mail to the Test Secretary. You will be notified by phone or email within 24 hours of the draw. Please include either or both. Entries will not be accepted without fees. Be sure to use an official AKC form or photocopy both sides. Don't forget to sign it. Please do not send an entry that requires a signature for acceptance...I may not be at home!

DRAWING OF ENTRIES - Entries shall be accepted up until the official closing date, even though the advertised limits have been reached. Entries will be drawn by the Test Secretary on **Thursday OCTOBER 30, 2025 at 7pm** at her home. The drawing shall be completely random among all entries received, whichever test is entered. Preference is given in the VST test to those dogs who have not yet earned a VST and in the TDX test to those who have not earned a TDX. When the advertised limit has been drawn, all remaining entries, subject to the same preferences set forth above, shall be assigned a position on the Alternate List corresponding to the order in which they were drawn. In the event that either test does not fill 1 TDX can be exchanged for 1 VST and vice versa. **THERE WILL BE A WORKER DRAW TO TAKE PLACE BEFORE THE REGULAR DRAW AS PER AKC REGULATIONS & THE GUIDELINES LISTED ON OUR COUPON. THERE WILL BE ONE TRACK AVAILABLE AS A WORKER TRACK.**

REFUNDS: Entries who pass an AKC approved test after the closing date of this test may withdraw from this test with full refund provided the test secretary is notified before the test date and there is an alternate to replace the entry. Those who decline to be placed on the alternate list may choose to have their check returned or destroyed. Any dog who makes the draw but cannot run may also have their fees returned only if an alternate competes in their place. ENTRY FEES SHALL NOT BE REFUNDED in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the Show Committee. Exhibitors are governed by rules and regulations of the AKC and local ordinances as noted in your signed entry form.

The club is not responsible for any illnesses sustained. The well-being of the dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the event before completion, no entry refund will be made.

DRAWING FOR TRACKS: The Judges will assemble the participants at the Preschool parking lot for a drawing by lot for the running order of each participant. The order in which tracks are run and the number of each track shall be determined by the Tracking Judges. Judging will begin as soon as possible after the draws. **We will email you the draw times in the Judging Program.**

ALTERNATE ENTRIES: In the event an accepted entry is absent on the day of the test, the Test Secretary will determine if any alternates are present.

Alternates will draw for available tracks based on their place on the alternate list. If no alternates are present the test secretary will draw for the absent dog, who may run the track if it arrives before the track is scheduled to be run. If it does not arrive by then it will be marked absent.

PRIZES - Each passing team shall receive a memento of their achievement

INCIDENTALS: Please join us for snacks following the test. The TDX cover varies from mowed grass to waist high grass and weeds. There are ponds, streams, pine forest, fields, an orchard and woods.
